	<p><u>Additional vehicle requirements:</u></p> <ul style="list-style-type: none"> ● Padfoot road rollers must not travel on any sealed roads. ● Overdimension vehicles require an overdimension permit and must comply with permit conditions. ● All lighting must be fitted as near as possible to the position specified in Schedule 2 of the Road Transport (Vehicle Registration) Regulation 2007. <p><u>Driver Licence type required:</u> Class C</p> <p><u>Mandatory conditions:</u></p> <ul style="list-style-type: none"> ● Daylight/floodlit worksite use only. ● Flashing amber beacon required and must be used when vehicle is moving. ● Vehicle to be floated from site to site (except that it can operate in areas designated below): <ul style="list-style-type: none"> ○ Use only within a defined road construction zone where a traffic control plan applies; ○ Use only by shortest, suitable route between depots and worksites. ● Vehicle can only travel on unsealed roads. ● Must not travel more than 5km between each site. <p><u>Additional conditions for vehicles with certain design features:</u> Hydraulic steering –</p>																			

- Restricted to a maximum speed of 45kmh.
- Steering failure warning device, warning label and Maximum Speed Advisory sign required.
